



## **\*\*\*CALIFORNIA CONSUMER PRIVACY ACT NOTICE -- NOTICE AT COLLECTION**

LAST UPDATED: September 2, 2025

In this notice, we are addressing specific disclosure requirements under the California Consumer Privacy Act (CCPA) (Cal. Civ. Code § 1798.100, et seq.), and the California Consumer Privacy Act Regulations (CCPA Regulations) (11 CCR § 7000, et seq.) for California residents even though the CCPA and the CCPA Regulations do not currently apply to us. Although PopID does not currently meet the definition of a “business” as defined in the CCPA (Civil Code § 1798.140(d)), and is therefore a “nonbusiness,” as defined in 11 CCR § 7001(p), PopID endeavors to implement best practices, including those provided in the CCPA and the CCPA Regulations.

This notice should be read together with PopID’s Privacy Policy and applies to all California residents who visit our Sites or use the Service. Capitalized terms have the meaning given in the Privacy Policy. Terms in ALL CAPS have the meanings given to them in the CCPA, including Cal. Civil Code § 1798.140, and the CCPA Regulations, including 11 Cal. Code Reg. § 7001.

All references in this notice regarding rights you may have under the CCPA and CCPA Regulations will only apply to California residents if and when we meet the definition of BUSINESS as defined in the CCPA (Civil Code § 1798.140(d).) Until that point in time, however, we will use commercially reasonable efforts to provide the rights described in this notice, but are not legally obligated to do so.

### **Personal Information Collection and Purposes of Use**

We COLLECT and USE PERSONAL INFORMATION, including Biometric Information (images of your face and/or palms, and information we generate from those Images, including vectors (sometimes referred to as signatures or templets), regarding California residents, as described in this notice (also 16-25 of the PopID Privacy Policy) and the above Privacy Policy, including the section titled “**THE INFORMATION WE COLLECT**”. Biometric Information that we COLLECT and USE from California residents constitutes SENSITIVE PERSONAL INFORMATION as that term is defined in California Civil Code section 1798.140(ae).

One type of “Personal Information” you share with us the details regarding your bank account from your financial institution (“Open Banking Data”) when you enroll your bank account as a Payment Method. When you add your bank account a Payment Method through Plaid (or a similar service we use), you agree to Plaid (or similar entity) establishing a connection between your bank account and us so that we may obtain Open Banking Data regarding your account as long as you maintain that bank account as a Payment Method. We use the Open Banking Data you share with us to make decisions regarding you and your PopID Account, including whether or not to approve transactions you attempt to make, establishing and adjusting limits on your account and transaction, as well as for us to decide, in our sole and absolute discretion, to offer or provide you with interest free, cash flow advances.

## **Sensitive Personal Information Collection and Use**

We collect and use your SENSITIVE PERSONAL INFORMATION, including Biometric Information, only the purposes stated below, and not for the purpose of inferring characteristics about you.

We only use or disclose the SENSITIVE PERSONAL INFORMATION, including Biometric Information, as follows:

- (a) To perform the services or provide the goods reasonably expected by an average consumer who requests those goods or services;
- (b) To prevent, detect, and investigate security incidents that compromise the availability, authenticity, integrity, or confidentiality of stored or transmitted personal information;
- (c) To resist malicious, deceptive, fraudulent, or illegal actions directed at PopID and to prosecute those responsible for those actions.
- (d) To ensure the physical safety of natural persons.
- (e) For short-term, transient use, including, but not limited to, nonpersonalized advertising shown as part of a consumer's current interaction with PopID, and we do not as part of this process (i) use that SENSITIVE PERSONAL INFORMATION to build a profile about you, or (2) disclose this SENSITIVE PERSONAL INFORMATION to another THIRD PARTY.
- (f) To perform services on behalf of PopID.
- (g) To verify or maintain the quality or safety of a product, service, or device that is owned, manufactured, manufactured for, or controlled by PopID, and to improve, upgrade, or enhance the service or device that is owned, manufactured by, manufactured for, or controlled by PopID.
- (h) To collect or process SENSITIVE PERSONAL INFORMATION where the collection or processing is not for the purpose of inferring characteristics about a consumer.

Because our collection and use of your SENSITIVE PERSONAL INFORMATION is already limited to what is allowed following a REQUEST TO LIMIT the collection and use of your SENSITIVE PERSONAL INFORMATION (i.e. what is permitted by California Civil Code

section 1798.121(a), and CCPA Regulations section 7027(m)), you do not have a right to request to limit our collection and use of your SENSITIVE PERSONAL INFORMATION.

## **CONSENT TO POPID'S VAULTING OF BIOMETRIC DATA WITH THIRD PARTY**

As part of our efforts to continuously improve and enhance the Service, in the future, we may transfer all user's registration image(s), along with certain personal information collected from each user including your First Name, Last Name, phone number, email address, and a unique identification number ("Biometric Vault Data"), to a third party, selected in our sole discretion, to vault this data for us. By registering for a PopID account, or using the Service, your expressly consent to us electing at some point in the future, to vault the Biometric Vault Data collected from you, including your registration image(s), with a third party, selected in our sole discretion, without obtaining further consent from you.

Prior to us transferring the Biometric Vault Data, we will provide you notice regarding the transfer and the date they will begin. However, you agree that we will not need to obtain further consent from you to proceed with the transfer of the Biometric Vault Data to the third party we select.

If you do not consent to PopID's right to transfer the Biometric Vault Data collected from you, including your registration image(s), to a third party in the future you must not register for a PopID account, and if you already have one, you must stop using and deactivate your PopID Account prior to the deadline stated. If you register for a PopID account, or continuing using the Service, and consent at this time, you can still avoid the transfer of your Biometric Vault Data to any third party selected by PopID by deactivating your PopID account prior to the date PopID identifies for when the transfers will begin.

### **We do not SELL PERSONAL INFORMATION to THIRD PARTIES**

We do not SELL PERSONAL INFORMATION, including Biometric Information, of any of our users, including California residents, to THIRD PARTIES as those terms are defined in the CCPA and CCPA Regulations. We did not SELL any PERSONAL INFORMATION, including Biometric Information, of any California residents to any THIRD PARTY in the preceding 12 months.

SELL is defined by the CCPA as "selling, renting, releasing, disclosing, disseminating, making available, transferring, or otherwise communicating orally, in writing, or by electronic or other means, a consumer's personal information by the business to a third party for monetary or other valuable consideration."

THIRD PARTY is defined by the CCPA as "a person who is not any of the following: (1) The business with whom the consumer intentionally interacts and that collects personal information from the consumer as part of the consumer's current interaction with the business under this title," "(2) A service provider to the business," or "(3) A contractor."

### **We do not SHARE PERSONAL INFORMATION with THIRD PARTIES**

**We do not SHARE PERSONAL INFORMATION, including Biometric Information, of any of our users, including California residents, with THIRD PARTIES, as those terms are defined in the CCPA and CCPA Regulations. We did not SHARE PERSONAL INFORMATION, including Biometric Information, of any California residents in the preceding 12 months, with any THIRD PARTY.**

SHARE is defined by the CCPA as "sharing, renting, releasing, disclosing, disseminating, making available, transferring, or otherwise communicating orally, in writing, or by electronic or other means, a consumer's personal information by the business to a third party for cross-context behavioral advertising, whether or not for monetary or other valuable consideration, including transactions between a business and a third party for cross-context behavioral advertising for the benefit of a business in which no money is exchanged." (Cal. Civ. Code § 1798.140(ah).

Because our collection and use of your SENSITIVE PERSONAL INFORMATION is already limited to what is allowed following a REQUEST TO LIMIT the collection and use of your SENSITIVE PERSONAL INFORMATION (i.e. what is permitted by California Civil Code section 1798.121(a), and CCPA Regulations section 7027(m)), you do not have a right to request to limit our collection and use of your SENSITIVE PERSONAL INFORMATION.

## **We do not SELL PERSONAL INFORMATION to THIRD PARTIES**

**We do not SELL PERSONAL INFORMATION, including Biometric Information, of any of our users, including California residents, to THIRD PARTIES as those terms are defined in the CCPA and CCPA Regulations. We did not SELL any PERSONAL INFORMATION, including Biometric Information, of any California residents to any THIRD PARTY in the preceding 12 months.**

SELL is defined by the CCPA as “selling, renting, releasing, disclosing, disseminating, making available, transferring, or otherwise communicating orally, in writing, or by electronic or other means, a consumer’s personal information by the business to a third party for monetary or other valuable consideration.”

THIRD PARTY is defined by the CCPA as “a person who is not any of the following: (1) The business with whom the consumer intentionally interacts and that collects personal information from the consumer as part of the consumer’s current interaction with the business under this title,” “(2) A service provider to the business,” or “(3) A contractor.”

## **We do not SHARE PERSONAL INFORMATION with THIRD PARTIES**

**We do not SHARE PERSONAL INFORMATION, including Biometric Information, of any of our users, including California residents, with THIRD PARTIES, as those terms are defined in the CCPA and CCPA Regulations. We did not SHARE PERSONAL INFORMATION, including Biometric Information, of any California residents in the preceding 12 months, with any THIRD PARTY.**

SHARE is defined by the CCPA as “sharing, renting, releasing, disclosing, disseminating, making available, transferring, or otherwise communicating orally, in writing, or by electronic or other means, a consumer’s personal information by the business to a third party for cross-context behavioral advertising, whether or not for monetary or other valuable consideration, including transactions between a business and a third party for cross-context behavioral advertising for the benefit of a business in which no money is exchanged.” (Cal. Civ. Code § 1798.140(ah)).

When the CCPA applies, California residents have the right to:

- (a) request information (RIGHT TO KNOW) about the PERSONAL INFORMATION we have COLLECTED, SOLD, or SHARED about them;

- (c) request the deletion (RIGHT TO DELETE) of PERSONAL INFORMATION collected from them, with certain exceptions.
